We partner with women to achieve stability and make meaningful gains in their housing, income, employment, mental health, physical health, and addiction recovery goals.

LETTER TO OUR VILLAGE

Dear Friends,

We are proud to share our Annual Report highlighting the achievements of the past fiscal year along with our plans to continue providing housing and supportive services to meet the critical needs of women experiencing homelessness in Washington, D.C.

N Street Village was founded during a tumultuous time in our city, in the aftermath of the assassination of Dr. Martin Luther King, Jr. For more than 50 years, hope and healing have been at the heart of our mission, and that has not changed.

As the largest provider of housing and supportive services for women experiencing homelessness in Washington D.C., N Street Village offers multiple hubs where clients can access supportive services to address their housing, health, and income needs. From our seven locations across four wards, clients can access a comprehensive continuum of care - including drop-in day services, emergency shelter, transitional shelter, and permanent supporting housing.

We are providing an innovative care model to meet the evolving needs of the women we serve, even as funding streams from public and private sectors are far more strained and far less certain. We are especially pleased with the progress made on the three strategic initiatives identified by the Village and designed to address the underlying causes of homelessness. We are focused on meeting the most pressing needs of our unhoused neighbors.

- We have expanded our geriatric-focused care, adding to the number of housing units and supportive care designed to support an aging population.
- We are tackling mental health as a root cause of homelessness with intentionality by embedding licensed behavioral health professionals within our housing and day programs.
- We have expanded and strengthened our functional literacy programing, a key driver of employment and economic stability.

We remain committed to building upon our 50-year legacy of meeting each woman where she is and providing hope and healing in an atmosphere of dignity and respect.

With supporters like you, N Street Village is creating an ecosystem of care, essential services, and support for every woman who comes to our doors. Thank you for investing in our Village.

ABOUT THE VILLAGE



WHO WE ARE

- A housing provider offering safe, stable, and dignified housing as the foundation for long-term recovery and personal growth.
- A safe space where women can heal from trauma, refresh with a shower, change into clean clothes, and simply breathe.
- A resource for health and wellness programs, employment assistance, social security benefits, case management, and more.
- A supportive community in an atmosphere of respect and dignity.

The Village addresses the complex needs of women experiencing homelessness by providing housing and an ecosystem of wraparound services at our seven locations throughout the city.



WHO WE SERVE

Last year, N Street Village provided supportive services and housing programs to **1,625 women and 57 families** who were extremely low income or experiencing homelessness in Washington, D.C.

Most women arrive to N Street Village:

- Having **experienced homelessness for more than a year** or having **multiple experiences of homelessness** within the past few years – an indicator of chronic homelessness (49%);
- Having **no income** (53%) or have income **falling below the federal poverty line** of \$1,304 per month (92%);
- Living with **mental illness, addiction, or both** (42%);
- Having experienced **domestic violence** (31%);
- Living with a **disability** (42%);
- Living with **HIV/AIDS** (4%);
- **Over the age of 50** (53%).



OUR EXPANDED BEHAVIORAL HEALTH SERVICES

In late 2024, N Street Village invited participants to share their needs related to mental health services. More than 50% of respondents reported that behavioral health services had a positive impact. Transportation, scheduling challenges, and financial limitations were cited as primary barriers to care. Individual and group therapy were the most requested services.

In response, the Village hired a Clinical Director of Behavioral Health Services and built an internal Behavioral Health Services (BHS) team. This new department provides individual therapy, medication management, and group-based interventions, such as stress management and self-compassion workshops at multiple program sites. Our new clinical staff provide 24/7 on-call support to coach staff across programs through challenging client situations, strengthening our timely, therapeutic responses in every circumstance.

In addition to expanded programming, this year N Street Village became an affiliate of Mental Health America, a national non-profit dedicated to the promotion of mental health, well-being, and condition prevention. As an affiliate of Mental Health America, N Street Village is connected to resources and technical assistance related to the implementation of best practices. In addition, the Village serves as a crisis prevention hub for women living with mental health issues.

PROGRAMMING FOR OLDER ADULTS

N Street Village provides a continuum of residential and non-residential services tailored to meet the needs of women aged 50 and older who are experiencing homelessness. This population faces heightened vulnerability due to economic insecurity, chronic health conditions, caregiving responsibilities, and lifelong barriers to education and employment. Many have no retirement savings and face housing instability after job loss or health decline.

Our residential services include a nine-month transitional shelter program that serves up to 16 women annually. This program offers on-site medical care coordination, mental health services, substance use recovery support, and trauma-informed case management. Participants engage in personalized service planning, life skills classes, wellness activities, and job readiness training. Residents of the transitional program for older adults are prioritized for placement in Permanent Supportive Housing (PSH) at Miriam's House or other N Street Village programs.



Non-residential offerings designed for older adults include job readiness workshops, financial literacy education, peer support groups, and functional literacy instruction focused on digital tools, health literacy, and communication skills.

By addressing housing, health, and economic stability in a holistic way, these programs empower older women to reduce their risk of returning to homelessness, build pathways toward lasting independence, and age with dignity.

N STREET VILLAGE'S FUNCTIONAL LITERACY INITIATIVE

N Street Village's functional literacy initiative equips women experiencing homelessness with the tools needed to achieve greater independence and stability. The initiative focuses on building functional literacy based on client needs and covers key domains—such as digital, financial, health, and everyday communication. These skills help participants navigate public systems, access services, and pursue employment opportunities.

Delivered in a trauma-informed setting, the program integrates foundational skill-building with practical life applications. Participants receive instruction in basic reading, smartphone and computer use, financial literacy, and health information management. The initiative builds knowledge and fosters confidence, laying the groundwork for long-term success in housing, work, and community life.

Economic empowerment is a core pillar of our work. Sharon's Place, our transitional housing program for 21 women who are employed or job-seeking, combines housing with behavioral health services and case management to support long-term stability. The Marj & Mak Vocational Center (MMVC) provides employment counseling, job training, digital literacy, and financial coaching for both residents and non-residents, helping women move beyond survival. In the last year, MMVC held 126 digital and functional literacy classes for nearly 600 participants.



EVENTS AROUND THE VILLAGE



FRIENDS & FAMILY GARDEN DAY

This spring, more than 20 volunteers and staff gathered to plant fresh blooms in the courtyard of our Flagship building. Despite the drizzle, our community came together to bring a burst of color that welcomed all our clients – new and returning. The central courtyard and garden are hallmarks of N Street Village's Flagship building and planting them each spring ensures our clients have a peaceful and beautiful place to rest the entire summer and fall.

SHERO COMMUNITY DAY

On October 25, 2025, N Street Village held its annual SHERO Walk and Community Day. Volunteers, clients, and community members came together to walk in support of women experiencing homelessness and to celebrate the strength, resilience, and community spirit at the Village. Every Village location came together in front of our Flagship building at 1333 N Street, NW to dance, walk, design SHERO masks, and hear directly from our clients.

ANNUAL GALA & AUCTION



On March 6, 2025, N Street Village celebrated the resilience of our community at the Annual Gala & Auction. Each year we honor three women who have demonstrated strength and perseverance in the face of extreme adversity. Our 2025 Steinbruck Honorees were DeAndra Smith, Lynorre McCray, and Magnolia Beccera.

We also recognized former Board Member, Ambassadors Council co-founder, and long-time volunteer Cindy Aron, along with her husband Mark, for their dedication and support of the Village. By the end of the evening, we raised \$1.9 million to invest in N Street Village programs.



ABOUT CINDY & MARK ARON

An author and now retired professor of history, Cindy tutored women at the Village who were interested in improving their literacy skills. Cindy is also a founding member of the Ambassadors Council, whose vision is to make all of Washington, DC familiar with the work of N Street Village. She continues to devote countless hours to volunteering and is a key leader in our functional literacy initiative.

In 2013, Cindy joined the N Street Village Board of Directors where she served for 11 years. As a member of the Executive Committee as well as Chair of the Governance Committee for many years, her voice was pivotal in shaping N Street Village's direction as it grew from just two locations to its current seven sites across the city.

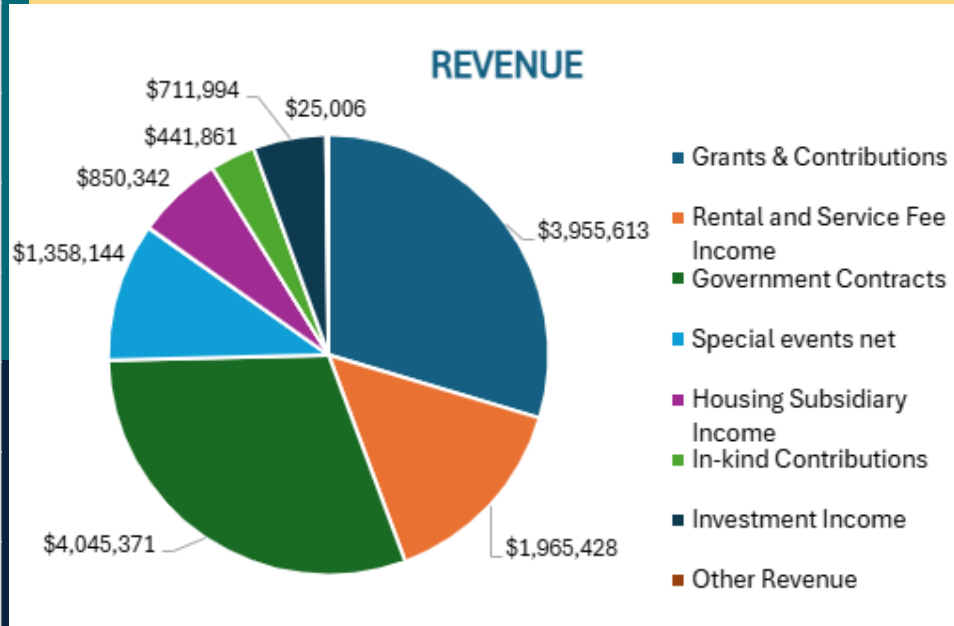

OUR FY25 FINANCIALS

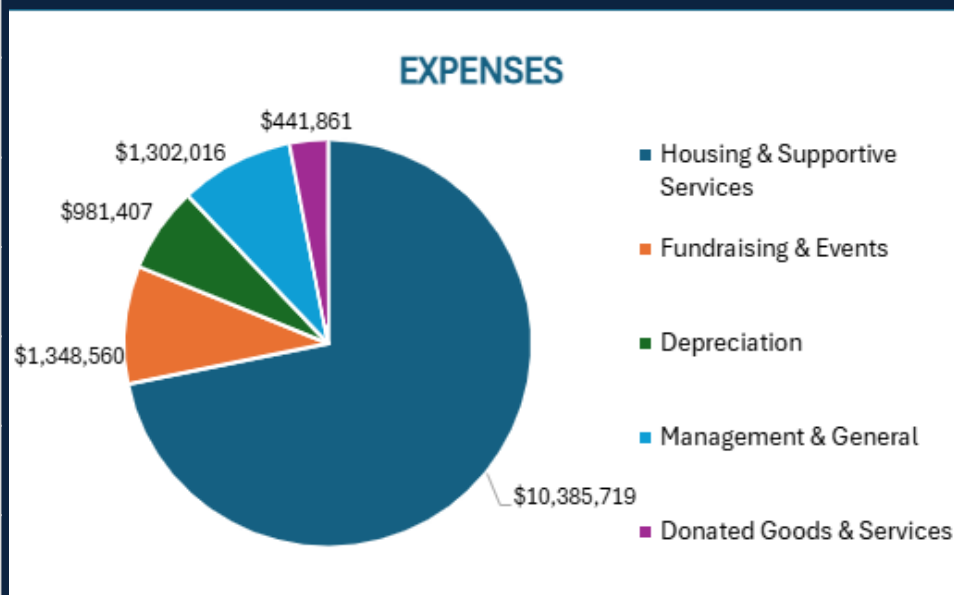

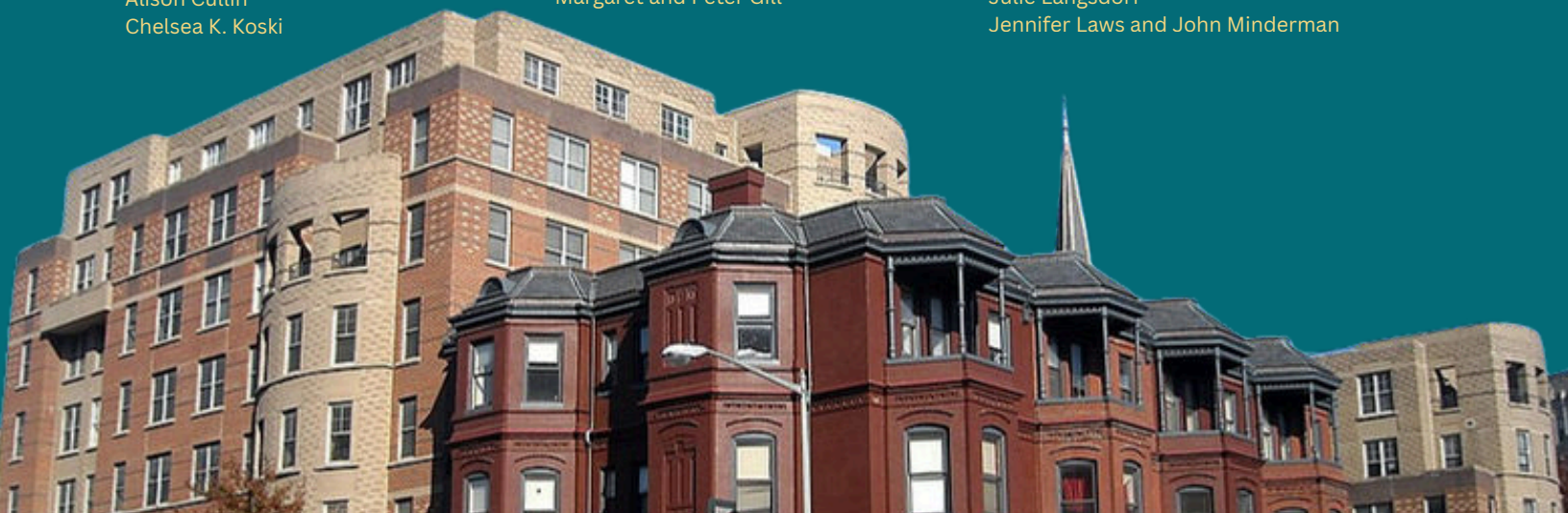

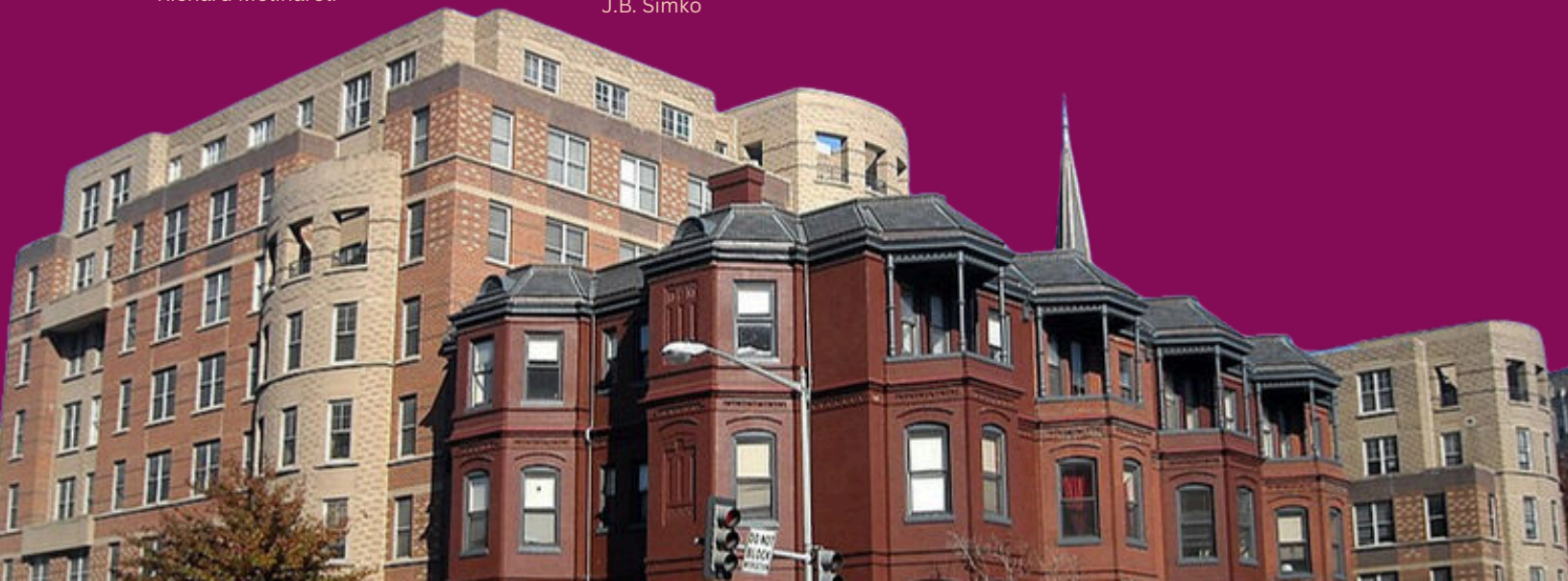

VOLUNTEER SPOTLIGHT

DANCING THROUGH THE DECADES:

MARGIE'S 40-YEAR JOURNEY WITH N STREET VILLAGE

When Margie first walked through the doors of N Street Village in the early 1980s, the Village looked very different. There were no dedicated program buildings, no formal dance studio—just a few townhouses and a shared mission: to serve women with dignity and compassion.

Driven by a desire to give back to women in her community, Margie began by serving meals. But she soon saw another need—one that had less to do with nourishment and more to do with joy, expression, and healing. With a background in dance and a heart for service, she proposed a new offering: a low-pressure dance class focused not on technique, but on movement, freedom, and connection.



"It's not about the steps," Margie said. "It's about getting up and moving, however you want to. I give a little direction, but really, it's about giving everyone the freedom to express themselves."

And so began a tradition that's lasted over four decades.

Margie's classes have taken place in living rooms, church basements, and multipurpose spaces. She's seen the Village transform from a small shelter operation to a multifaceted support system for women across DC—and she's been part of that transformation every step of the way.

"They come in and just light up," she said. "There's one woman who just stands in the middle and sways—but she smiles. That's enough. That's joy."

Her class always ends with something special: a guided meditation and quick stress-relief exercise to recenter and reenergize.

For Margie, volunteering isn't just a way to serve others—it's also deeply personal. She's brought her children to serve alongside her, made lifelong connections with clients and staff, and seen the spirit of the Village ripple far beyond its walls. "I tell people this is my second family," she said. "And I learn something every day I come here."

Margie's story reminds us that healing isn't always loud or linear. Sometimes, it looks like a small dance class. Sometimes, it's a quiet sway in the middle of the room. And always, it's rooted in dignity, joy, and community.

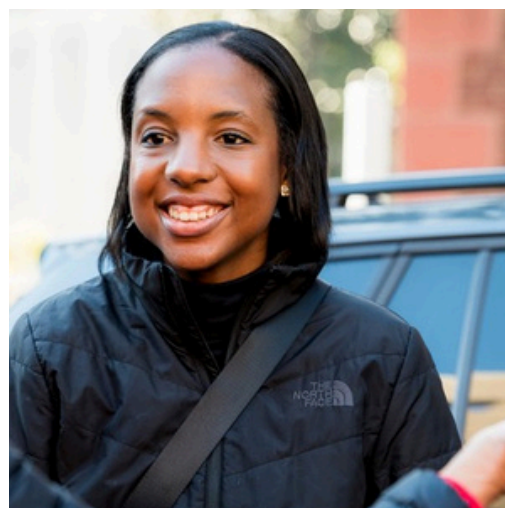

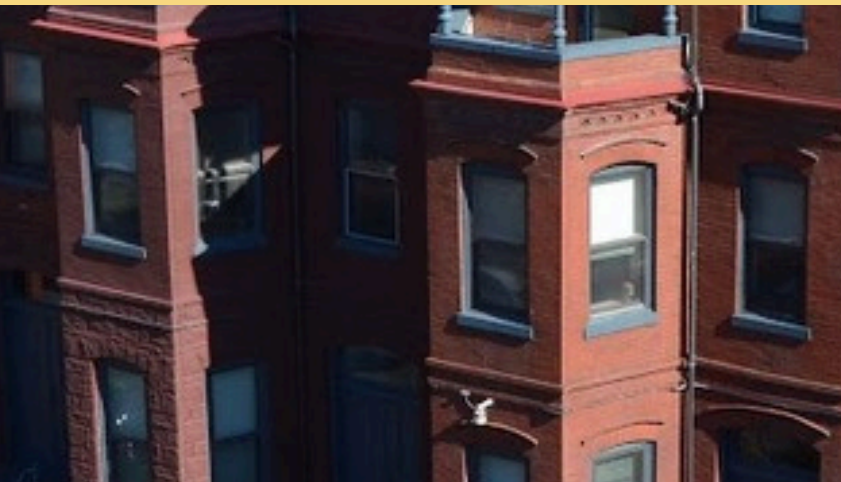
